EMISSION NORMS FOR FARM EQUIPMENT SET TO GET ANOTHER EXTENSION

The government may defer the implementation of new emission norms for the farm equipment sector yet again by one more quarter. The move may offer a temporary reprieve for three months to the manufacturers of combine harvesters, power tillers and tractors with an engine capacity higher than 50 horsepower (HP), who are already under pressure from sustained price increases.

The Centre had earlier decided to make Bharat Stage TREM IV emission regulations, which are equivalent to Euro Stage IV norms, applicable from October 1, 2022. However, this is the third time the government will postpone the date of implementation of these stricter emission norms for the tractor industry.

FUNDAMENTALS REMAIN STRONG FOR COMPACTION **EQUIPMENT IN INDIA**

India's ambitious road building programmes will continue to require large volumes of compaction equipment. The scale of planned infrastructure development in the country, especially the road sector, is huge, which will continue to drive the compaction equipment market for many years to come. However, demand is likely to decline by 8% in 2022 due to slowdown in road laying activities, implementation of CEV-IV emission norms from April 2021 and high commodity prices but is projected to grow thereafter to reach 5,000 units by 2026. CEV-IV is the new emission regulation for tyred construction equipment in India. This has impacted the cost of the new machines. In addition, rising commodity prices and inflation have also had an impact this year. Machine prices have risen by 5 to 7% this year as a result of the two factors.













PASSENGER VEHICLE SALES MAY HAVE HIT NEW RECORD IN OCTOBER

Automakers are mentioned to have clocked amongst their best-ever month-to-month retail sales in October, outpacing dispatches for the primary time this 12 months, as customers drove dwelling their dream autos amid festive fervour after muted celebrations in the previous two years on account of the pandemic. Estimated 375,000-385,000 cars, sedans and utility vehicles were sold to customers, which brought down inventory in the channel by 25% this month. Retail sales of passenger vehicles (PV) had peaked at 382,000 units in December 2018, compared with 370,416 and 370.300 units in October 2020 and December 2019, respectively.

AUTOMOBILE INDUSTRY FALLS SHORT ON CLIMATE GOALS



Major automakers will need to sell about half the number of petrol and diesel vehicles than under current projections, in order to be aligned with key climate goals. To limit global warming to 1.5°C, no more than 315 million new vehicles running on fossil fuels can still be sold worldwide, as per the group's report. However, at present, major automakers are on track to sell 712 million diesel and petrol vehicles by 2040.

THREE WHEELERS VEHICLES RETAIL SALES FOR OCTOBER 2022

For the month of October 2022 the total three-wheelers sold in the Indian market were 66,763 units. This indicates an increase in three-wheelers retail in India by 26,512 units which translates to 65.86% year-on-year increase in total threewheelers retail. The figures for total threewheelers retailed in the Indian market for October 2021 stood at 40,251 units.



GOVT SET TO REVERT TO ZERO FEE PERMIT ISSUE FOR COMMERCIAL EVS

The government is all set to convey again the coverage for issuing permits for commercial electrical autos (EVs) at zero fee. The Centre had discarded the follow during the last two years so as to push penetration of inexperienced autos. However, now it has determined to revert to the previous technique of issuing such permits.

OCTOBER 2022 **CAR SALES**

Around 3,36,229 passenger cars were sold in the Indian market in October 2022. The sales increased by over 29% when compared to October last year and the industry dropped by 5.2% in comparison to September 2022. It also crossed the 3 Lakh dispatch figure for the seventh month in this calendar year. Diwali & Dusshera were celebrated in the country last month and the volumes resonated the same. The dispatches for Grand Vitara and Hyryder were in full swing and both models combined sold over 11.4k units. The Passenger Car industry continues to be in green which is a positive sign.



PASSENGER VEHICLE SALES PUTS A STRONG SHOW IN OCT.



Passenger Vehicle sales stood at 3,28,645 units. This indicates an increase in total passenger vehicle retail in India by 94,823 units which translates to 40.55% year-on-year increase in total passenger vehicle retail. The figures for total passenger vehicles retailed in the Indian market for October 2021 stood at 2,33,822 units.

COMMERCIAL VEHICLES RETAIL SALES FOR OCTOBER 2022

For the month of October 2022 the total commercial vehicles sold in the Indian market were 74,443 units. This indicates an increase in total commercial vehicle retail in India by 15,080 units which translates to 25.40% year-on-year increase in total commercial vehicle retail. The figures for total commercial vehicles retailed in the Indian market for October 2021 stood at 59.363 units.
